049.2 Acting CEO of NZ Fish and Game (8.3)

Chair reported on the appointment of an Acting CE, Di Taylor. He welcomed Di to her new role on behalf of CSI Fish and Game.

049.3 Sports Fish and Game Management Plan (8.4)

Chair thanked those members that provided comment on the Draft Sports Fish and Game Management Plan.

050.1 Draft Sports Fish and Game Management Plan (9.1)

Councillors sought clarification on issues related to the process and timetable for reviewing the SFGMP. They were advised that once Council has approved the prepublication draft it will go to principal affected parties for consideration and comment. On completion of that process the draft Plan will come back to Council at its 16 September meeting for adoption and approval for public notification to begin the public consultation process for receiving submissions on the draft SFGMP.

# 050.2 <u>2021/22 Licence Fee Update</u> (9.2)

CE confirmed that the Minister of Conservation has approved the sports fishing and game bird hunting licence fees for 2021/22, meaning that the CSI budget for the 2021/22 financial year is approved at \$729,030.

## 050.3 Season Bag Implementation Update (9.3)

CE summarised progress for introducing a season bag for salmon. He clarified that Cabinet has amended regulations to allow a "season bag limit" to be applied in the next Anglers Notice. Both, CSI and North Canterbury (NC) Fish and Game councils have recommended a season bag limit for salmon in their regions. A joint NZ, CSI and NC council working party is working through arrangements to implement a season bag limit for salmon for the 2021/22 season.

### 050.4 Upper Tekapo Canal Fishery

THAT THE REPORT ON COMPARISONS OF SPORTS FISH CATCH, AND ANGLER USE OF THE UPPER TEKAPO CANAL FISHERY DURING THE 2019 AND 2020 RAINBOW TROUT SPAWNING SEASONS BE RECEIVED.

Council noted the high rate of satisfaction, 81%, as a very good indicator and that greater than 50% of anglers caught a fish. They complemented Rhys Adams on his very well-presented report. Council <u>AGREED</u> that information contained in the report should be publicised as much as possible. R Adams advised that the report would be linked on the CSIFG website.

Council was advised that they will be provided with a canal fishery management scoping document at its September meeting that will include upper Tekapo Canal opportunities.

CE provided the latest Risk Register. Council encouraged all staff to have their Covid-19 vaccine as soon as it becomes available to them.
