22-037 MANAGEMENT OF MEETINGS: (Chair)

037.1 Meeting Procedure, Code of Conduct, Behaviour, Respect

Chair expressed his willingness to have open and honest discussion with each other and added that whilst differences of opinion is well and good there will be times when a Councillor will leave the meeting not being supported by fellow Councillors who may have differences of opinions in what the outcome is. He asked that staff opinions be respected as they will come with scientific background and detail. That doesn't mean Councillors will always agree with them but asked them to be mindful of common courtesy and respect in each other and each other's opinions.



CE added that staff attend Council meeting with reports that have data and science behind it and reference that data to come to the conclusions that they raise. This makes reports more defensible because in a court of law or environment court as they are given increased credibility and competence. He added that staff attend Council meetings in a similar way to a court where they are there to provide the best advice they can with data and science behind it.

He made the comparison of evidence-based information compared to observation-based information and stressed that Council should be making decisions based on the most reliable information they have in front of them.

037.2 Governance Overview

Chair then spoke on general Governance practices that Councillors should operate under. He advised that governance training will be provided to CSI and funded by NZ Council. This session will take place at a time to include appointed CSI Councillors.

037.3 Notice for Filling Extraordinary Vacancies

CE advised that no requests were received from stakeholders to hold an election.

037.4 Councillors Governance Survey

Chair thanked Councillors for filling out the survey which helps identify what skills/gaps are needed to fill to bring to the Council. Councillors had a general discussion on a process for appointing new Councillors, agreeing that governance skills are an important requirement.

It was <u>AGREED</u> to advertise for expressions of interest and ask applicants to complete a survey. It was <u>AGREED</u> that Dean Rattray, Colin Weatherall and Paul Centofanti be the members of the panel to bring recommendations to Council for appointing members. To allow for time frames to undertake this process Council <u>AGREED</u> to delay the next meeting of Council and hold it on Thursday 4th August.
