Rationale:

The Salmon By-Catch Committee has rarely been utilised for many years with low salmon numbers and vessels named in the Agreement no longer existing or fishing.

It was recognised that Council can re-establish Committees in the future if the need arises.

24-059 CHIEF EXECUTIVE'S REPORT:

059.1 Upper Ahuriri River Pressure Sensitive Fisheries Management (6.1)

B Harper presented his report explaining that the National Policy on Pressure Sensitive Fisheries Management addresses fisheries where high angling pressure negatively impacts the angling experience. Recent data shows that the upper Ahuriri River, renowned for its exceptional trout fishing, meets the criteria of being classified as a Pressure Sensitive Fishery and may be experiencing excessive pressure. He proposed a phased management strategy involving firstly conducting an online survey in the 2024/25 season to assess angler displacement, and potentially introducing new management tools where justifiable, based on findings in subsequent seasons.

He explained the various systems that Council could look to put in place dependant on the outcome of the 2024/25 survey. These options include a voluntary beat system; a backcountry fisheries licence; a designated waters licence or a make it a controlled

fishery. General discussion was held and B Harper responded to queries and comments from Council.

Councillors extended their appreciation to B Harper for his highly detailed and informative report.
