#### 8. OPERATIONAL WORKPLAN REPORT

The manager updated Council on matters when asked.

Producing a fishing diary like the hunter diary was considered a good idea, FO Lucas will look at developing such.

Looking into the future for the next step from fishing the fish out ponds to river fishing Councillor Gauld asked if it is possible to release into local rivers such as the Wai-iti River, the Manager advised that he will start iwi consultation and explore future release sites around the Waimea catchment.

Concern was expressed that we did not have reliable statistics around the salmon runs/numbers in the Wairau River. The fishing diary discussed earlier will be one way of gathering information on salmon harvest as well as getting out and talking to anglers.

The draft MOU received from the Marlborough Kaikoura Trail Trust was discussed and it was agreed to hold off signing any documents until the resource consent application process is underway.

**<u>DOC LIAISON</u>** – Dirk de Vries was welcomed to the meeting.

Points discussed included new whitebait regulations, concessions, and information this region would like to see gathered from concession holders.
