- NZDA in conjunction with the DOC will be running a goat competition August to late November.

15. CHAIR REPORT

- The chair reported that he had attended by zoom the monthly chairs meeting, discussion is mainly around the review.
- With the support of the Council the chair asked the manager to draft a letter for his signature to all chairs asking their Councils to support increasing the future price of the annual whole season gamebird licence in NZ so that the licence is in parity with

gamebird management output costs, and look at the introduction of a non-resident gamebird licence.

• Councillor Willis attended the chairs zoom meeting on behalf of the chair for the NZC and Chairs workshop for the 23-24 budget and contestable fund applications, Councillor Willis reported that he found the process to be less than satisfactory with no opportunity to discuss regions CF applications. After discussion it was agreed that there were no clear terms of reference for this meeting and for future meetings of this type there needs to be clarity on what the role is for the chairs.

17. CORRESPONDENCE

Late correspondence from Marlborough Research Centre was tabled for information. The letter outlined a rent increase of 50% for the Blenheim Field Office, it was noted that this will have an effect on our budget for the rest of this year and next year, and consideration should be given to looking for alternative accommodation in Blenheim.
