Matters Arising

The Council enquired on the outcome of the IRD letter on taxable income for Fish & Game regions. The NZC representative, Noel Birchall, informed Council that a meeting was held with Inland Revenue and the New Zealand Fish & Game are awaiting their response.

The Underwood Wetland Wildlife Management Plan has been approved and signed off by the Department of Conservation. The access road into the property will commence as soon as ground conditions allow and a boundary fence will be built soon after. The Department of Conservation has agreed to pay for 25% of the fencing costs. The Manager will approach Mr Dave Underwood and his son, Aubrey Underwood for 25% contribution each towards the

cost of the fence, making it a 4 way split with Fish and Game also contributing 25% of the fencing costs.

Manager's Report

The Council considered the operational report with discussion on the following items:

1311 Access Negotiations

Landcorp Farming is currently producing a national Memorandum of Understanding that will set some guidelines for hunting access for licence holders on all Landcorp Farms in New Zealand.

The Manager is working with the Farm Manager of the Rangiputa Landcorp Farm in the Far North on the ways to undertake a Canada goose control. The Manager is arranging for Graham Hughes a retired Field Officer from Central South Island Fish and Game to come north to provide some expertise in managing and controlling these birds.

Northland Fish & Game Council has a number of goose decoys and the Manager is considering leaving these decoys at Rangiputa for any licence holders to use whilst hunting Canada Geese on this farm. The Manager will email all game bird licence holders about the decoys providing the Farm Manager will allow access, to hunt the Canada Geese on the farm.

1316 Secondary School Clay Target Competition

The Manager commented on the very close competition of the 2016 Northland Secondary School Clay Target Competition. There were also some outstanding results at the National Clay Target Competition held in Christchurch in September. This competition was attended by a small number of Northland Secondary schools and students. For the first time, the Northland Girls team won the Inter-Regional Fish & Game Open Teams Shield.

1531 Prosecutions

The Manager clarified that the new powers for ranging does not apply to Fish & Game rangers. The new powers will be restricted to full-time DOC rangers. The powers for all Fish & Game rangers are unchanged.

NZFG Council Update

Councillor Birchall attended a one day NZFGC meeting in Wellington on the 23rd September 2016. A brief account was written by Councillor Birchall and circulated to the Council. The draft minutes from this meeting had not been received.

Councillor Birchall commented on the following points of interest:

- The Minister has not confirmed the appointments to the NZ Game Bird Habitat Trust.
- Proposed changes to the Act on ranger's powers. The select committee want to restrict the new powers to DOC rangers only.
- A set of Standing Orders for the NZ Council has been adopted and are now submitted to the Minister for approval. When approval is given, they will become a template for regions to follow.
- A TV programme on fly fishing on Sky Channel 52 has commenced on Monday evenings in association with Red Stag Hunters Club. Fish & Game sponsorship allows us to promote key some national issues.
- Meeting with the IRD on Fish & Game's tax exempt status.
- NZ Professional Guides Ass. The final points in the Guides Licence proposal were discussed and an agreement has been reached to proceed to the Minister for approval.
- Safety to the general public on eating trout after 1080 has been spread from the air over waterways. There is clear evidence of trout taking the 1080 pellets which drop into the water.
- The 2015-16 fish season saw an increase in participants of 6,450 but there was a reduction of licence income. A review of prices will occur prior to the 2017-18 fish season if the same trend appears in the 2016-17 fish season.

At this point, the Office Administrator distributed a spread sheet on the National Fish Licence Sales Year to Date to the 12th October 2016 which showed a comparison of the 2015-16 fish season and 2016-17 fish season. The licence sales for the Northland region are above from the previous year.

Correspondence

Ban of use of Lead Shot

The Chairman asked all Councillors for comments and criticisms on the draft letter to the Chairman of the NZFG Council on the ban of use of lead shot. The Council agreed that no changes to the letter should occur.

It was moved: Northland Fish & Game Council would not support the ban of lead

shot unless the Minister requires a ban on all lead shot over waterways for all types of hunting with shotguns, the ammunition was more affordable, there is a phase in period of five years and

Wildlife Act 1953 Schedule 1 Black Swan and Paradise Shelduck

The Manager corresponded with Michael Gee, Senior Policy Analyst, Department of Conservation in regards to a letter sent from NRC, to the Minister of Conservation requesting a change in the status of the Black Swan and Paradise Shelduck in the Northland region. The Manager sent all information on the number of permits issued to landowners out of season, the number of land owners who hired gas guns to disperse game birds, aerial trend count data and the annual harvest of game birds by hunters during the open game bird hunting season. The Manager has not received a reply from the Minister of Conservation on this matter.

Fish Monitoring Plan in the Kai Iwi Lakes

The Manager informed the Council that the Northland Regional Council applied for a grant from Envirolink for a fish monitoring plan in the Kai Iwi Lakes.

The NRC applied for \$20,000 funding to employ scientist, Dr Eleanor Gee, from NIWA to provide a report which includes:

- a review of the literature and all available fish data on the status and ecology of dune lake galaxias in the Kai Iwi Lakes/Taharoa Domain;
- a critical evaluation of the available information on biotic interactions between dune lake galaxias and exotic fish species in the lakes, in particular trout and gambusia;
 There is some debate as to the impacts of trout/gambusia on dune lake galaxids populations and any impact that trout may/may not have in controlling gambusia numbers.

Recommendations for a suitable long-term fish monitoring plan for the lakes to undertake a literature review of the relationships between the dune lake galaxids population and other native fish populations within the lakes. This grant has been approved.

Property Purchase Proposal

The Council readdressed a property for sale on the outskirts of Whangarei from the previous Council meeting. The Manager had not investigated into the costs of developing the property due to his heavy workload. Councillor Reardon visited the property and believed the property had lots of potential with possibly subdividing part of the property. He considered the price was exorbitant and thought that the Council should wait to see if the property would sell at the current asking price.
