Bi-monthly report on outputs

1111 Drift Diving

Drift Dives completed on the Mawheraiti River. Report completed and attached.

1113 Spawning Surveys

Spawning counts completed on MacDonalds and Windbag creeks, with an improvement in numbers from last year. Spawning surveys completed at known spawning sites in the Taramakau and Hokitika catchments. Only brown and rainbow trout observed.

1114 Trend Counts

Greylard, Pukeko, and Swan counts completed.

1115 Sportsfishery Research

Electric fishing completed at Mawheraiti research sites.

1116 Designated Waters Fisheries Management

Meeting with Designated Waters coordinators fortnightly reviewing current DWs and data collection. Survey of licence holders completed.

1121 National Hunter Survey

Surveys are underway with hunters reports mixed results for opening. Those that are targeting recently harvested maize crops appear to have done well.

1171 Regulations/Gazette Notices

Report compiled for Council and Minister on gazette changes for designated waters. Summary included in Council papers.

1181 Game Bird Control

Three more crop predation complaints have been received, two for Paradise Shelduck and one for Pukeko. One paradise shelduck complaint in regarding to aviation safety was responded to by issuing a permit. The

other paradise shelduck complaint was addressed by assisting with organising hunting pressuring during the winter game bird season. The Pukeko complaint was addressed with a permit.

Advice on public access and liaison with the WAC regarding public roads.

1312 Assisted Hunting

Three organised hunts planned during the winter game bird season in areas where complaints have previously been received. All West Coast game bird licence holders with a valid email address received a hunting bulletin at the start of the season which included an organised hunts calendar.

1331 Website/Ezines/Social Media

Relevant material has been posted on website. Facebook engagements have been done, focusing on game bird hunting opportunities and promoting both barrels. Reel life and both barrels completed.

1332 Fish & Game Magazine

Preparations have been made for the Sportsfish Supplement and budgetary change for the magazine costs to regional reserves.

1341 Sportsfisheries Guides

Nothing to report.

1361 Clubs, Outdoor Recreation Groups

Per-season gun club field shoots were attended by staff and sponsorship of some licences was provided.

1371 Okuru Hut

General maintenance and installation of spare key holder.

1411 Cons.Bds. Iwi, Allied Groups

Nothing to report in this period.

1421 Media/Communication

Media releases before opening weekend as well as in the Top of the South Farming paper regarding game bird hunting. Communications regarding compliance at Lake Brunner.

1511 Compliance

Compliance carried out focusing on salmon, Lake Brunner, and game bird opening weekend. Six noncompliance's detected, two fishing without licences and four hunting without licences. One angler on the Waitangitaona and the other at Lake Brunner. Gamebird opening compliance completed with the police

in the Lake Brunner area, no offences detected. Second team, not accompanied by police, detected four hunters hunting without licences in the Grey Valley.

1521 Ranger Training

Met with rangers and reviewed performance in preparation of the re-warranting occurring in October, six rangers will be re-warranted. CERT training occurring at the end of August.

1531 Prosecutions

The two anglers detected fishing without licence have completed diversion. The four hunting with licence cases are still active. Fish and Game have new requirements for the storage of confiscated items. We have had to upgrade our facilities.

1611 Licence Production & Distribution

Licence sales to NZ residents so far this season are below budget and last year's sales. Upgrades to licence purchases are being received more frequently.

1621 Agent Liaison

Regular visit to agents. Frequently stocked with access guides, how to guides, child licence pads and excess F&G magazine in the office. West Coast Agents have been contacted ahead of the Game Bird licences going on sale, there was some disappointment in the delay of the Game Regulations being produced and delivered on time to the store ahead of licence sales going live.
