1. Welcome and Chair's Introduction

- Meeting started at 2:30pm Friday 30th April.
- Chair welcomed NZC Councillors and Regional Chair's.
- Chair outlined some amendments to the order of the agenda so that Councillors with particular interest can be present.
- Chair noted Edward Ellison, who is the Chair of the New Zealand Conservation Authority, will be joining the meeting 1st May at 10:30.

2. Apologies

Debbie Oakley for Sunday.

3. Conflicts of Interest

Darryl Reardon (Northland region), Dave Coll (North Canterbury region) and Ray Grubb (Otago region) registered conflicts of interest with contestable funding applications and they did not vote on those items

Discussion on 22/23 Licence Fee

Councillors and Regional chairs discussed at length the options for the licence fee, noting;

- o The high CPI of 5.9%
- Cost of amalgamation / change management, which will be paid for by New Zealand Fish and Game.
- o It is unrealistic for Fish & Game to keep absorbing losses.
- o Licence holders already have the pressure of increased daily costs, i.e. fuel prices etc.
- Costs for our statutory obligations have also increased.
- Uncertainty of how many non-resident anglers we should expect with borders re-opening.
- ACTION: Investigate possibility of the development of a policy for licence fees to match CPI and convey to the Minister.
- o A possible of risk of non-compliance.

11. Complete 2022 2023 Budget Round Decisions

11a Approve CF Applications to Set Total Budget & Set Licence Fees for Consultation

Carmel Veitch spoke to this paper

- The status of the RMA reserve and the contestable fund applications was discussed, noting that the balance to be carried forward will be \$150K and that the contestable fund bid for \$500K be reduced to \$350K to maintain a balance of \$500K.
- The Northland CF application for a field officer was discussed. It was agreed to approve \$70,000 as a one off from Northland reserves and for a review of the Northland budget to be undertaken by the CFO of NZC.
- The Otago CF application for performance increments was discussed, noting the Rem review and its implications. This application was not approved by NZC.
- The funding for the PhD research, which is co-funded by Cawthron was discussed. It was suggested that it be funded from the Research fund and that fund be split out \$75,000 Research and \$25,000 for the PhD Research for 3 years and to segment the research fund to show our contribution.
- Costs of Fish & Game's restructure were noted. It was suggested that there be consultation with regions to devise a shared formula to fund amalgamation costs. However, after advice from the Acting CEO and CFO that NZC have no powers to levy Council's reserves it was decided to add the \$500k to the Licence fee hence a late Contestable funding application that hadn't been included in the agenda papers.

Council moved to a workshop session and staff left the meeting.

- **3.** Agree to consult on a 2022 2023 adult whole season sports fish licence fee of \$145 and an adult whole season game licence fee of \$107 (inclusive of a \$5 fee (agreed meeting 155) for the Game Bird Habitat Stamp) inclusive of GST.

11b Licence Endorsement Fees

Councillors discussed the backcountry licence endorsement fee, noting;

- Query of the pricing mechanism, noting the difference in the number of backcountry fisheries within regions.
- Noted that licence holders tick all the boxes for a free backcountry endorsement which does not give a clear indication of how many are actually using the endorsement. After Wellington Fish & Game introduced a fee (for liability insurance) the number of endorsements asked for dropped substantially.
- o Council discussed the staff proposal for a backcountry licence and this was not supported.
- 1. Agree to consult on a \$5 fee for sea run salmon licence endorsement

The Chair called the meeting to order at 8:00am

Continuation of agenda item 11

- o Carmel Veitch tabled papers that included the approved contestable funding applications
- Councillors discussed the estimated figure of \$500K for the amalgamation process and how it would be funded.
- There should be future discussion on individual licence categories and the pricing of them. ACTION: The Licence Working Party will start a program to review this.
- Uncertainty of the number of Non-resident licences expected for the next year, and the pricing of the NR licences.
- o Invite regions to share ways to improve Pressure Sensitive Waters.
- O A day licence for designated fisheries for Non-resident anglers.
- The acting CE explained the process to get this type of licence added and noted the cost to Fish & Game for ESL to make the necessary changes, which could not go ahead until we get approval from the Minister.
- o Councillors were encouraged to have the PSF paper included in the meeting agendas.
- o Encourage regions to nominate designated waters.
- That an annual fee for whole season non-resident licences be recommended for consultation at \$250 and regions are encouraged to invest time in monitoring Pressure Sensitive Waters.
 A uniform policy giving effect to etiquette and compliance and data gathering for a longterm objective.

To establish a new licence category called a Designated Waters Licence, which regions could choose to apply to waterways they believe would benefit from it via the Anglers Notice and Sports Fish Licences, Fees and Forms Notice. This will have a daily fee for non-residents and will be free for full season resident licence holders.
- 3. Note the Acting CE will provide further advice via email and Council will confirm this decision after receiving said advice.
- 4. Authorised the acting CE to contract with ESL on system to deliver this.
